

First "Vidzeme" Stakeholder Working Group meeting

Aim of the event	The Stakeholder Working Group meeting was organised as part of a larger event, the "Vidzeme innovation week 2020", which was held in the region between 24-28.02.2020. The Latvian State Forest Research Insitute (LSFRI Silava) and BIOCOM AG participated in the Vidzeme innovation week with a Bio-based Pop-up Store that took place in the context of the BE-Rural project. Local stakeholders were invited to visit the pop-up store, and a meeting with them was held as a satellite along the "Responsible Innovation 2020" conference.	

Short summary: On 27 February 2020, the first Stakeholder Working Group meeting on the BE-Rural project was organised during the conference "Responsible Innovation 2020". Participating stakeholders were introduced to the BE-Rural project and had the chance to all give their perspectives on what a regional bioeconomy could be. An introduction was also given to the future collaborations that will take place in the region around the bioeconomy sector. The potential link between these future collaborations and the relevant regional policy strategies was also discussed. On the long term, this should help find new solutions and business models for forest residues, create new products from forest residues, and launch new partnerships in advertisement campaigns where the bioeconomy concept could be explained and promoted.

After this introductory part, group conversations were organised for stakeholders to get to know one another better. During the networking activities with stakeholders, the following topics were discussed: objectives and upcoming activities of the project, and new business model implementation in the regions. All participating stakeholders showed some interest in the upcoming activities and were willing to receive regular information about upcoming project updates as well as to meet again in the near future. In terms of next steps, discussions on the bioeconomy strategy/roadmap in the region must be held with the Stakeholder Working Group,

who should also receive an introduction to the BE-Rural Handbook on regional and local biobased economies.
